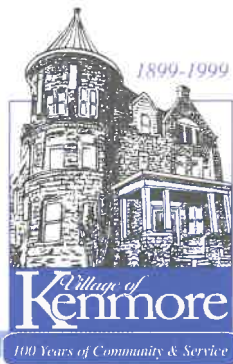


**NOTICE OF PUBLIC HEARING ON THE PROPOSED DEVELOPMENT OF
